

2012-2013 Verification Worksheet Federal Student Aid Programs



Your FAFSA application was selected for review in a process called "Verification." In this process, we are required to compare information from your FAFSA application with an official IRS Tax Return Transcript for you and your parents which can be obtained online at www.irs.gov or by calling 800-908-9946. You must also submit 2011 W-2 forms for all taxpayers as well as this completed worksheet. The law says we have the right to ask you for this information before awarding federal aid. If there are differences between your application information and your financial documents, we may need to send corrections electronically to have your information reprocessed.

What you should do

- Collect your and your parent(s) financial documents (2011 IRS Tax Return Transcript).
- Complete this worksheet. **ALL SECTIONS MUST BE FILLED IN.** Write N/A (not applicable) or enter a zero if the field does not pertain to you. You and at least one parent **MUST** sign the worksheet.
- Send or take the completed worksheet, plus copies of your and your parent(s)' 2011 IRS Tax Return Transcript and 2011 W-2 forms to the Financial Aid Office at Wartburg College.
We must review the requested information under the financial aid program rules (CFR Title 34, Part 668).
